SANTA YNEZ VALLEY "STAY & SNAP" PHOTO CONTEST RULES

1. Must be 18 years or older to enter. One entry per person. Decisions of the judges are final.
2. To enter, submit by mail an unframed, un-mounted glossy color OR black-and-white photograph (size 4" x 6" or 5" x 7") with this entry form (completed legibly) securely affixed to the back of the photo.
3. Submit a copy of receipt showing proof of entrant staying at least one night at a Santa Ynez Valley, California resort, hotel, motel, inn or RV park in Ballard, Buellton, Los Alamos, Los Olivos, Santa Ynez or Solvang during contest period of September 8 through December 31, 2009.
4. Save a high-quality DIGITAL print of your photos (which will be required) in the event you are a winner.
5. Photo must be suitable for family viewing & depict the beauty, serenity & uniqueness of Santa Ynez Valley.
6. Contestants must know the names and addresses of all identifiable people in their photographs. Entrant will be responsible for obtaining all consents necessary of any persons featured in any photograph for SYVVA to use the photograph for any purpose contemplated by these rules. Failure to obtain consent will result in disqualification.
7. All entries become the property of SYVVA. Receipt of entries will not be acknowledged and entries will not be returned. SYVVA assumes no responsibility for submitted photographs.
8. Entrant confirms and promises that entry is original and does not infringe the intellectual property rights of any third party. By participating, entrant agrees that ownership of the entry and all intellectual property rights in the entry is assigned to SYVVA, and will do all things necessary to give effect to that assignment. Entrant agrees to sign any further documentation required by SYVVA to give effect to this clause.
9. Entries must be postmarked by January 15, 2010. Award winners will be notified in February 2010. Winners will be notified by mail. Prizes must be claimed within 30 days of notification. If not claimed by this date, the prizes will be forfeited. All claims thereto following this date will be null and void.
10. All federal, provincial, state and local taxes are the sole responsibility of the winners.
